

PFTT Shop Terms and Conditions

This document sets out the terms and conditions you agree to when purchasing items via our website ("Shop"). The Shop is operated by the Pest Free Token Trust, referred to in this document as "we" and "us".

Introduction

In purchasing something from our Shop, you agree to be bound by the following terms and conditions ("Terms"), including any additional terms, conditions, and policies referenced here or on our website (e.g., our Terms of Use, Privacy Policy, and PFT Trap Health and Safety instructions).

These Terms apply to all users of the Shop.

Please read these Terms carefully before using our Shop. If you do not agree to all the Terms, then you may not use our Shop. If these Terms are considered an offer, acceptance is expressly limited to these Terms.

Any new products, features, or tools added to the current Shop shall also be subject to the Terms. You can review the most current version of the Terms at any time on our website.

We reserve the right to update, change or replace any part of these Terms by posting updates and/or changes to our website. It is your responsibility to check these periodically for changes. Your continued use of or access to the Shop following the posting of any changes constitutes acceptance of those changes.

Our Shop is facilitated via WooCommerce and hosted on our server. WooCommerce provide us with the online e-commerce platform that allows us to sell our products to you.

Shop Terms

By using our Shop, you agree to the Terms in this document, including the following:

- You are over eighteen (18), or give us consent to allow any of your minor dependents to use this Shop
- You shall not use our products for any illegal or unauthorised purpose
- You shall not use our products inconsistently with any instructions we have issued (including any health and safety documentation in relation to our traps)
- You may not violate any laws in your jurisdiction (eg, copyright laws)
- You must not transmit any viruses or any code of a destructive nature

• You must not reproduce, duplicate, copy, sell, resell, or exploit any portion of the Shop, use of the Shop, or access to the Shop or any contact on the website through which the Shop is provided, without express written permission by us

We reserve the right to refuse access to the Shop to anyone for any reason at any time.

Any breach or violation of any of the Terms by you will result in an immediate termination of any agreement we might have with you.

Except for the PFT Trap (made locally), we use a range of other companies to fulfil orders via the Shop (eg, Printful) ("Third-Party Supplier"). You can read their terms and conditions on their websites.

Certain products may be available exclusively online through the Shop. These products may have limited quantities and are subject to return or exchange only according to our Return Policy below.

We have made every effort to display as accurately as possible the colours and images of our products that appear at the Shop. We cannot guarantee that your computer monitor's display of any colour will be accurate.

The PFT trap you receive may not look the same as the one in the photo. We make these traps from a variety of treated timber, including off cuts. Furthermore, stencil painting of the traps

can vary and is not always perfect. Any trap you purchase will be functional, though may not always be the 'prettiest'. For example, some of the timber panelling may have minor defects or chips. The trap is a product designed for the garden, not a mantle piece.

We reserve the right, but are not obligated, to limit, refuse, or cancel the sales of our products to any person, geographic region, or jurisdiction. We may exercise this right on a case-by-case basis.

In the event that we make a change to or cancel an order, we may attempt to notify you by contacting the e-mail and/or billing address/phone number provided at the time the order was made. We reserve the right to limit or prohibit orders that, in our sole judgment, appear to be placed by dealers, resellers, or distributors.

You agree to provide current, complete, and accurate purchase and account information for all purchases made at our Shop. Should you have an account with us, you agree to promptly update your account and other information, including your email address and credit card numbers and expiration dates, so that we can complete your transactions and contact you as needed.

We reserve the right to limit the quantities of any products that we offer.

Return Policy

Any claims for misprinted/damaged/defective items must be submitted within 30 days after the product has been received. For packages lost in transit, all claims must be submitted no later than 30 days after the estimated delivery date. Claims deemed an error on our part are covered at our expense.

Returns or refunds will not be given for traps for aesthetic reasons, so long as they are functional. Please read the Products section above before ordering a trap.

If you notice an issue on the products or anything else on the order, please submit a problem report to <u>trustees@pestfreetoken.co.nz</u>.

Wrong Address - If you provide an address that is considered insufficient by the courier, the shipment will be returned to us or the Third-Party Supplier's facility. You will be liable for reshipment costs once we have confirmed an updated address with you (if and as applicable).

Unclaimed - Shipments that go unclaimed are returned to us or the Third-Party Supplier's facility and you will be liable for the cost of a reshipment (if and as applicable).

Both we and the Third-Party Supplier do not accept returns of sealed goods, such as but not limited to items which are not suitable for return due to health or hygiene reasons (eg, cups,

mugs, bottles, face masks). You hereby agree that any returned orders not suitable for resale won't be available for reshipping and will be disposed of.

Returned by Customer–You must contact us before returning any products. We do not refund orders for buyer's remorse. Returns for products, as well as size exchanges are only offered at our discretion and your expense. You may need to place a new order at your expense for a product in another size.

We reserve the rights to refuse returns at our sole discretion.

Any purchase of a PFT trap shall not be conditional or for consideration of any catch payment, and you agree to not claim otherwise. For the avoidance of doubt, you agree to not make any claim that you purchased or ordered a trap believing that any catch payment was part of any contractual relationship or obligation. We will take steps to make obvious that any such scheme is subject to terms and conditions, but where this is not immediately clear it is no substitution for you not reading and understanding these Terms first.

Governing law

These Terms and any separate agreements whereby we provide you access to our Shop and products and services shall be governed by and construed in accordance with the laws of New Zealand.
